Re: Parking - Red Deer

Dear Mr. Cole:

I am writing you regarding the parking requirements for the Professional Building. We have been advised by City Hall in Red Deer that although we have provided 100 parking stalls in our Parkade, we should make provisions for an additional 14 stalls to abide by the bylaw of the City of Red Deer. At the present time, out of the 100 stalls we have available, only 6 are rented, though our building is over 60% rented. This seems to show that with our present Parkade, we have far too much parking for our requirements, and it would seem to us that making more stalls available at the present time would be premature.

Although we are quite prepared, should the need arise, to make this parking available, we would like to point out that should we have taken the alternative of paying certain monies to the City of Red Deer parking fund, we would not by now, have the parking we have available. Indeed, should we have made our payments into the parking fund on a six-year basis as it was suggested to us at one point, we would have at the present time a maximum of one-sixth of our total parking, i.e.  $114/6 = 19$  cars. Indeed, the City of Red Deer would have taken over five years to produce the parking of 100 cars that we have at the present time, and it would have been on the sixth year that the last 19 stalls would have been made available.

Under this basis, we would ask the City of Red Deer to put this Co. on the same footing with themselves as to providing parking for this building, and postpone for another five years the requirement of an additional 14 parking stalls. At that time, we would like to have the opportunity as has been discussed with you to provide the City of Red Deer with 14 stalls, or paying the City the amount of money required into the parking fund.

Hoping this is satisfactory to you and hoping to receive your confirmation of this arrangement should it be acceptable, I am,

Mr. Cole's comments to City Council:

August 6, 1965

RE: Parking agreement -- Professional Building

When the building permit was issued for the above mentioned building, an agreement was signed between the City and MacLab Enterprises Ltd. to the effect that they would meet the requirements of the By-law prior to their building being occupied, either by paying installments into our parking fund or by providing parking, or any combination thereof in accordance with the By-law. The By-law requires for this building the provision of 114 stalls, or alternatively, payment into the fund for any deficiency at the rate of \$333 per stall.

A two-storey Parkade has been constructed by MacLab Enterprises Ltd. across the lane from their building, and this Parkade will accommodate 100 cars. The building plans indicated that the balance of the City requirement (14 stalls) would be provided on the land to the East of the Professional Building on the corner of Ross Street and 48th Avenue.

The surfacing of parking areas having access to a street or lane, is subject to City approval and it has been the policy of the City for some years to require such new parking areas to be surfaced to a standard not less than the public thoroughfare from which it gains access. In this case, the site for the 14 stalls would obtain access from the lane which is paved, and therefore this parking area the City would normally require to be paved.

The above mentioned request of MacLab Enterprises points out that at present the Professional Building is only 60% occupied and that very little use is now being made of the Parkade structure. While the Company agrees that, in the future, the additional 14 stalls may be required, it does not seem reasonable to pave the site East of the Professional building to provide 14 stalls at this time.

The Company also presents the argument that, if they had elected to pay into the fund for the 114 stalls rather than immediately provide 100 stalls, they would not have been obliged to contribute for the last 19 stalls (1/6 of the total) until their sixth and final installment became due five years after taking out the permit.

The Company is asking that the City of Red Deer agree to defer the provision of the 14 outstanding stalls or alternatively, a payment into the fund for these stalls, until five years after the date the permit was issued.

The Managing Director verbally indicated to me that, if this arrangement should be accepted by the City, his Company would landscape the site to the East of the Professional Building until required for parking or further development.

The Zoning Officer, Mr. K. Jorgenson, does not believe that the proposal of the Company would, in any way, contravene the letter or the spirit of the By-law .

It is recommended that the City approve of the proposal subject to an agreement being executed satisfactory to the City Solicitor.

Being a By-Law to amend By-Law 2011 (The Zoning By-Law of the City of Red Deer).

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF RED DEER DULY ASSEMBLED ENACTS AS FOLLOWS:

By-Law No. 2011 is amended:

The Zoning Map as defined in Section 2(3) (cc) and the Residential sub-district map referred to in Section 5(5) of the Zoning By-Law, both of which form part of the said Zoning By-Law pursuant to the provisions of Section 2(1) thereof, are hereby amended in accordance with Zoning Map A-54 hereunto attached and forming part of this by-law, and signed by the Mayor and City Clerk and impressed with the corporate seal of the City of Red Deer.

BY-LAW NO. 2203

A BY-LAW TO AUTHORIZE THE BORROWING OF MONEY BY THE ISSUE AND SALE OF DEBENTURES FOR THE PURPOSE OF REPLACING AND IMPROVING CERTAIN EXISTING BRIDGES IN THE CITY OF RED DEER.

WHEREAS it is deemed expedient to replace and improve certain bridges in the City of Red Deer, as set out in Schedules "A" & "B" hereto attached (which schedules are hereby declared to be and to form part of this By-law) at an estimated cost of Seventy Four Thousand Dollars (\$74,000.00).

AND WHEREAS plans, specifications and estimates of the said work set out in Schedules A & B have been made by Haddin, Davis and Brown Ltd., Professional Engineers, whereby the total cost of replacing and improving the said bridges is estimated to be Seventy Four Thousand Dollars (\$74,000.00).

AND WHEREAS it is deemed expedient to borrow money pursuant to Section 646 of The City Act and to pay the cost of the aforesaid works by the issue and sale of debentures of The City of Red Deer in the principal amount of Seventy Four Thousand Dollars (\$74,000.00) bearing interest at a rate not exceeding Six (6%) per centum per annum, payable annually, which is the amount of the debt intended to be created by this By-Law;

AND WHEREAS the said indebtedness is to be repaid over a period of twenty (20) years in annual installments, with interest not exceeding Six (6%) per centum, payable annually;

AND WHEREAS the total amount of the assessment of lands, buildings and improvements and special franchises in the City according to the last revised assessment roll is Forty-four Million, Four Hundred and Eighty Thousand, One Hundred and Forty Five Dollars (\$44,480,145.00);

AND WHEREAS the amount of the existing debenture debt of the City is Eight Million, Seventy-Six Thousand, Eight Hundred and Thirty-Four Dollars (\$8,076,834.00), and no part of the principal or interest thereof is in arrears;

AND WHEREAS the estimated life of the said construction is twenty (20) years;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF RED DEER DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. The Municipal Council of The City of Red Deer is hereby empowered and authorized to enter into such contracts for the construction or carrying out of the proposed works as may be necessary.
2. That money shall be borrowed by the issue and sale of debentures of The City of Red Deer in the principal amount of Seventy Four Thousand Dollars (\$74,000).
3. The debentures to be issued under this By-law shall be for the said sum of Seventy Four Thousand Dollars (\$74,000.00) and shall be dated the first day of October 1965, or upon such other date as may be appropriate having regard to the date of the borrowing of the money and shall be payable in twenty (20) annual installments of principal on the first day of October in each of the years 1966 to 1985 inclusive, or on such other date in each year as may be appropriate having regard to the date of the borrowing, the respective amount of principal maturing in each of such years shall be as nearly as possible equal, the annual installments being rounded off to the nearest \$100.00 or multiple thereof.

4. That the said debentures maturing in the years 1966 to 1985, both inclusive, shall bear interest from the first day of October, 1965 or such other date as may be appropriate having regard to the date of the borrowing at a rate not exceeding Six (6%) per centum per annum, payable annually.

5. That the said debentures and coupons, if any, thereto attached, shall be payable in lawful money of Canada at the Canadian Imperial Bank of Commerce, in the cities of Edmonton and Red Deer.

6. That the said debentures shall be sealed with the seal of the City of Red Deer and signed either by the Mayor or some person authorized by By-Law to sign the same in his stead, and the interest coupons attached to the debentures shall bear the signatures of the Mayor or some person authorized by the By-law to sign the same in his stead, and of the City Treasurer or some person authorized by By-Law to sign the same in his stead. The signature of the Mayor or other person authorized by By-Law to sign in his stead on the debentures, and the signatures of the Mayor or other person authorized by By-Law to sign the same in his stead, and of the City Treasurer or other person authorized by By-Law to sign the same in his stead on the interest coupons attached to the debentures may be reproduced by lithographing or printing or any other method of mechanical reproduction. The signature of the City Treasurer on the memorandum of registration of said debentures in the Debenture Register of the City endorsed on said debentures may be lithographed or printed or otherwise mechanically reproduced.

7. That in each of the years 1966 to 1985, both inclusive, the respective amounts necessary to pay the interest and the principal of the said debentures as such interest and principal become due and payable, shall be levied and raised by an annual rate sufficient therefor over and above all other rates of all the rateable property in The City of Red Deer, at the same time and in the same manner as other rates.

8. The said indebtedness is contracted on the credit and security of The City of Red Deer at large.

9. The net amount realized by the issue and sale of debentures issued under this By-Law shall be applied only for the purpose for which this indebtedness was created unless otherwise authorized by an Order of the Local Authorities Board.

10. This By-Law shall take effect on the day of the final passing thereof.
