For many years your Council has made an annual grant to the Salvation Army for our work with unmarried mothers. We do appreciate very much indeed the interest shown and the support given.

It may interest you to know that our work in this field has been very successful in that we are more interested in rehabilitation of the individual rather than the hospitalization. For this purpose we have refrained from billing any municipality in order that our opportunities for rehabilitation might be more effective.

The average stay of a girl with us is approximately six weeks. For this reason the grants we receive do not completely cover our financial requirements. BY-LAWS:

The following amendments to by-law No. 1862 have been perused and approved by the City Solicitors.

BY-LAW NO. 1862

A by-law to amend By-law 1862, being the licensing by-law of the City of Red Deer.

THE MUNICIPAL COUNCIL OF THE CITY OF RED DEER ENACTS AS FOLLOWS:

By-law 1862 of the City of Red Deer is further amended by adding thereto: -

1. Beauty Parlour:

(a) Any person who engages in the business of a beauty parlour in the City of Red Deer, operator or ladies hairdresser and who does not pay a business tax to the City shall take out a license and shall pay therefore, to the City, an annual fee of \$15.00.

(b) For the purpose of this section a manicurist, face masseur or masseuse or any person practicing any form of beauty treatment shall be deemed to be a beauty parlour operator.

No comparison - Minimum Business Tax \$30.00

2. House Cleaning Service:

(a) Any person who operates any form of service for the cleaning of exterior of buildings or the interior of homes, including furnishings, in the City of Red Deer, shall take out a license and shall pay therefor to the City,

An annual fee of \$ 5.00 for a resident
An annual fee of \$15.00 for a non-resident.

(b) Provided this section shall not apply to any person operating as a charman or charlady.

Chimney sweep \$10.00 annual

3. Janitor Service:

Any firm or person employing two or more persons, who, by contract with the owner or renter of offices or business premises engages in the business of cleaning the interior of such offices or business premises or for the supply of Janitor or Caretaker service within the City shall take out a license and shall pay therefor to the City an annual license fee of \$25.00.

No comparison - Minimum Business Tax \$30.00

4. Insurance Agent:

Every person engaged in the sale of Insurance of any type in the City of Red Deer, and who does not pay a business tax to the City of Red Deer shall take out a license and shall pay therefor to the City an annual fee of \$25.00.

Resident Canvasser	\$20.00
Non Resident	\$50.00

5. Real Estate Agent:

Every person engaged in the sale of real estate of any type, in the City of Red Deer, and who does not pay a business tax or business license to the City of Red Deer shall take out a license and shall pay therefor to the City an annual fee of \$25.00

Same as (4)

7. Metal Worker:

Every person who engages in the business of metal or iron worker in the City of Red Deer, exclusive of sheet metal or tinsmith shall take out a license and shall pay to the City:

Resident - an annual fee of \$25.00

Non resident - an annual fee of \$50.00

Same as building sub-contractor.

8. General By-law:

The License Inspector with the approval of the Commissioners, may assess any business operating in the City of Red Deer that is not paying a business tax or license, and is not classified elsewhere in this by-law. The fee charged shall be in accordance with fees for any similar type of business already classified.

REPORTS:

Gentlemen:

During the month of December 1957, I wish to report ten (10) alarms which were answered by the Fire Department. The breakdown is as follows:

Fires in buildings - 4, Fire Outdoors - 1, Emergency -1, Needless Calls -2, Country Call - 1, False Alarm - 1.

Dec. 7th - 4:14 p.m. - Alarm received stating a pot of grease on fire in an oven at 5038 - 42 Avenue. Engine 5 and crew responded and on arrival found fire out. No damage.

Dec. 8th - 4:10 p.m. A lady called from the Co-op Block stating that she had locked her self out of her suite. Ladder #4 and 2 men were sent to the scene. Entry into the suite was made by the firemen through one of the windows in the suite with the use of the arial ladder.

Dec. 9th - 9:34 p.m. This alarm was phoned in on 2244 by a Telephone Operator at the A.G.T. office and her report was that there was a fire at Whyte Motors Used Car Lot. Engine #5 and crew responded and as they were passing the intersection of 49th St. on Gaetz Ave. they noticed fire coming out of the front windows of the Paint and Body Shop which is located behind Whyte Motors. It was immediately realized that there had been a mistake in reporting the correct address as to where the fire was. All remaining equipment and man power were dispatched to the scene as quickly as possible, once the extent of the fire was known. Within a very few minutes the fire was under control. It was fairly well confined to the ground floor with the exception of one room upstairs, directly above where the fire started. A fire place in this room contributed a great deal to the spread of the fire. As the portion of building behind the fire place was wide open, it acted as a flue to transmit heat from the fire directly below. The ground floor also contained several false ceilings. These all had to be torn out as fire had spread up into the ceiling joists.

It was later learend that several attempts had been made to report this fire on 2550 which is our alarm number. Our fire phone did ring and when our alarm operator answered it there was no reply at the other end. This was verified by the R.C.M.P. who have an extension on 2550 in their office. Our telephone equipment has since then been replaced with new equipment and work is underway at present to install a rotary circuit which will help make our alarm system much more dependable. At time of writing no estimate of the loss could be obtained.

Cause of the fire was gasoline that had been spilt by one of the two workmen working the shop at the time.

Dec. 10th - 9:06 p.m. Call came from Mrs. Lumley who resides at 5516 - 47 A Ave. Apparently a cigarette had dropped down in a chesterfield chair and she could not recover same. No. 5 Company responded and on arrival cigarette was removed from chair. No damage.

Dec. 12th - 7:21 p.m. H.D. Rogers of 5928 - 52 Ave. reported smoke in his basement. No. 5 Company answered the alarm and on arrival found the chimney stack to the chimney open on opposite end to the one being used. This was plugged and basement was ventilated. No damage.

Dec. 14th - 5:35 a.m. Alarm in from 4118 - 39 St. stating house was full of smoke. When Engine #5 and crew arrived the owner, Earl Brown, informed the trouble had been located. He apparently plugged in an electric tea kettle and set same on a rag. Heat from the tea kettle element had started the rag smoldering. No damage.

Dec. 21st - 6:20 p.m. Country call in from Ben DeBoon, one mile east of town. Permission was received from Commissioner Newman to send Engine #3 and crew. On arrival found the owner had been dumping ashes at the back corner of the house and sparks from these ashes had ignited the house. Fire was fairly well under control when Engine #3 arrived, however, the portion of the building involved was given a good soaking to prevent any rekindling. Damage was very slight.

Mr. DeBoon was invoiced the amount of \$60.00 for this call.

Dec. 25th - 6:04 p.m. The party that phoned in this alarm was quite concerned about the sparks the wind was blowing up the Convent hill on 60th St. On checking we found that the P.W. Department had dug a trench and were thawing the ground with a mixture of coal and straw. As the wind was quite strong there was quite a shower of sparks blowing up into the brush on the hillside so we extinguished this bed of coals within the trench. No damage.

Dec. 31st - 11:09 a.m. This call turned out to be a false alarm. Mrs. Morton of 4434 - 53 St. informed us that she had received a call from a young girl who said their house was on fire and that there were five kiddies in the house. Mrs. Morton was unable to get the name, address, or phone number of the girl that called. We checked the district where Mrs. Morton lived as well as several other districts in town but found nothing.

Dec. 31st - 4:15 p.m. Call in from 3340 - Gaetz Ave.. On arrival #5 Company found a small hut involved. Caused by garbage burning adjacent to this hut. Extinguished with H.P. reel and 1½ inch line and fog nozzle. Damage to the old hut was very slight.

On December 2nd the Fire Chief and myself attended a safety meeting at the Brewery to help them organize a Fire Dept. for their plant. By no means do they intend to rely strictly upon their own department but should a fire occur their department will evacuate and try to confine the fire until the City Department arrives.

Several members of staff from different departments of the plant have been selected and at present we are giving them two hours of instruction on Fire Fighting every Monday morning. Plans are to have this course completed some time in March.

Mr. H. Winger, one of our alarm operators took sick on Dec. 4th.. He is still in hospital and at present have no idea as to when he will return. Mr. E. Ruby was hired on Dec. 11th to take Mr. Winger's place until the latter does return.

On Dec. 9th the Officers and men of the permanent brigade completed their St. Johns First Aid Course. This course was conducted here in the Fire Hall and it consisted of two hour lectures, for a ten week period.

The Fire Inspector inspected 20 Commercial and 5 Industrial buildings. He also inspected four private homes on request from the owners and issued necessary recommendation for the above.

He kept a constant check on the different places in town that were selling Christmas trees and issued instructions on how to tag these trees for the treatment of fire proofing same.

During the month of December he also spent considerable time getting toys ready for Christmas delivery. Also read and recorded the temperatures for the month.

Regular Tuesday night practices were held the first three Tuesdays of this month with an average attendance of 40 members present. As the last two Tuesdays fell on Christmas and New Years Eve, practices for these nights were cancelled.

A total of 36 wrong numbers were received on the Fire Phone during the month of December.

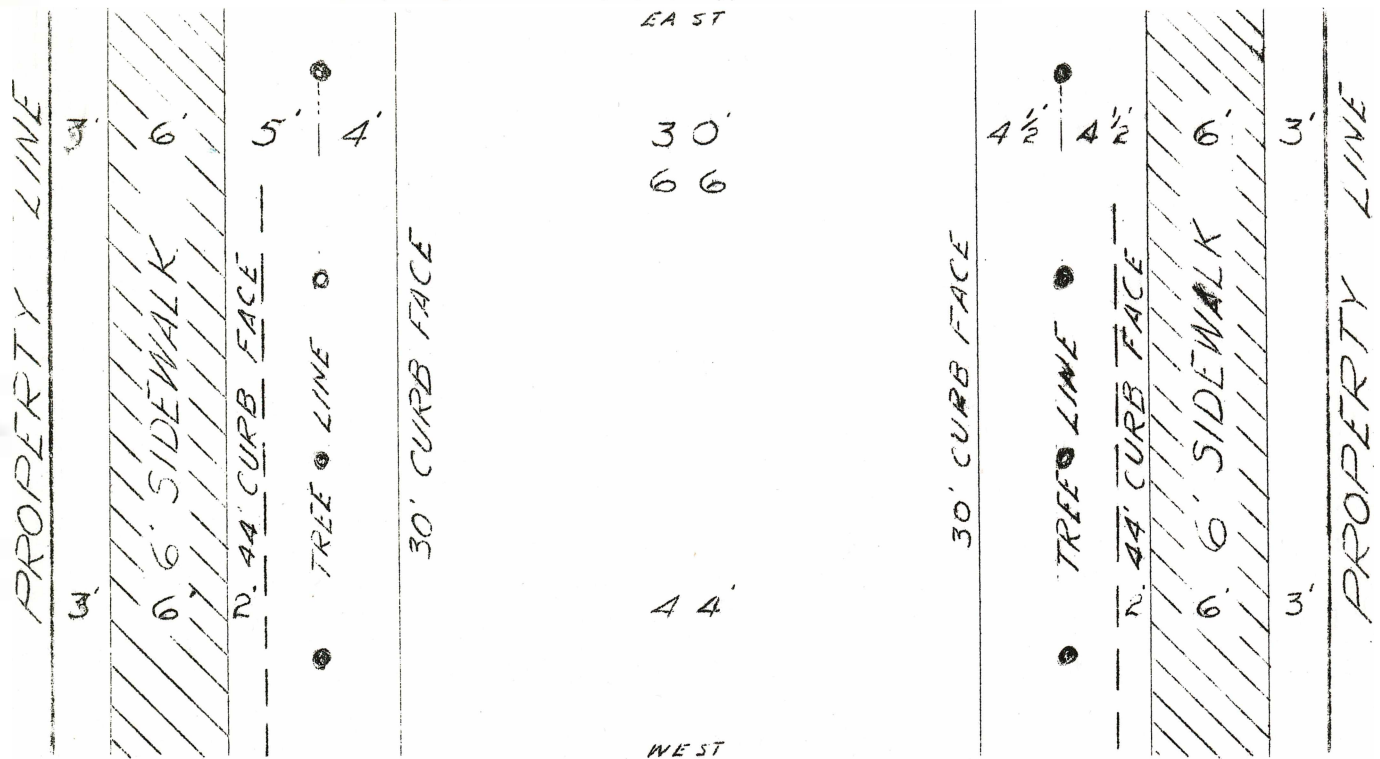

Re: Widening of 53 St. Between 49th - 50th Avenues

According to the traffic report the streets between 49th and 50th Ave. will carry a great deal of traffic when the one-way street system is instituted. In order to handle this traffic these streets will have to be (a) wide, or (b) part or all of the parking will have to be removed. At present 53 St. has a road width of 30'. If this St. were widened to 44' (as is 48th, 49th, 51st, and 52nd Streets in the same blocks) the trees would have to be removed.

At the present time Council have agreed to widening these streets to the lane from Gaetz Ave. to 44' widths, this was done last year during Gaetz Ave. reconstruction.

The advice of the Council would be very much appreciated in this matter. Contracts are being prepared for roads at the present time.

NOTE:

We recommend that this block should be widened to 44' which would leave a 2' wide boulevard. This would hardly be wide enough to justify maintaining a boulevard and we suggest it be cemented in.

If Council agree to widening this block to 44' we would recommend that the residents of same be notified of our plans.
