RE: MAJOR CONTINUOUS CORRIDOR PROJECT

Information previously presented to Council indicated that a Memorandum of Agreement was signed December 3, 1987 with CP Rail, Alberta Transportation, and The City of Red Deer, with regard to the rail relocation component of the above noted Project. This Agreement was subject to the approvals of City Council, Provincial Cabinet, and the CP Rail Board of Directors.

As a further step towards finalizing the Agreement between CP Rail and Alberta Transportation, we are now in receipt of the Agreement between the City and the Province covering the complete Corridor Project. The highlights of the Agreement are as follows:

1. The total Provincial share shall be no more than \$62 million for the period of January 1, 1988 to the end of the 1993 calendar year.
2. The total City share covering the same construction period will be a maximum of \$6.9 million.
3. The Provincial funds will be made available to the City subject to annual Legislature approval, in the following amounts:
 - 1988 - \$40.0 million
 - 1989 - \$10.0 million
 - 1990 - \$ 5.0 million
 - 1991 - \$ 5.0 million
 - 1992 - \$ 2.0 million
4. All interest earned will be available to the Project over and above grant amounts as a measure to offset inflation.
5. The City is not obligated to budget any given amount towards the Corridor in any given year, but must contribute its share on or before December 31, 1993.

6. Revenue from the sale of surplus lands will be credited to the respective parties in the same ratio, 90% Provincial/10% City.

7. The City agrees to consult the Province on any proposed reclassification of land adjacent to the Corridor.

8. The City generally may not prohibit the use of the Corridor by oversized and overweight commercial vehicles.

9. The City agrees to obtain acceptance from the Province for the following:


- a. Changes to design/construction.
- b. Road signs.
- c. Noise attenuation.
- d. Speed limit.
- e. Any changes to the Corridor after completion.

10. The components of the Project are summarized on the map attached to the end of the Agreement.

A Debenture Borrowing By-law was presented to Council February 22, 1988 covering the land and rail component of this Agreement. The road component will follow when more detailed cost estimates are available. First reading was given to the By-law for the initial amount of \$53,170,700 with the City's share being \$5.317 million.

Clause 22 of the Agreement requires that City Council ratify this Agreement prior to the Province transferring any funds to the City. Council is respectfully requested to consider and authorize this Agreement as soon as possible so that funds can be advanced to the City prior to March 31, 1988.

The final Agreement with CP Rail is in the draft stage and will be presented to Council at a future meeting.

The announcement by The Honourable Mr. Adair of the approval of Provincial funding for the Major Continuous Corridor Project in Red Deer marks the successful culmination of years of planning, and paves the way for finalization of plans with CP Rail, and for construction to begin on the \$70 million, six year program.

This is certainly one of the most important decisions affecting Red Deer since its incorporation, as it will have an enormously beneficial impact on the economy, and will provide a substantially improved transportation system which will benefit all citizens of Red Deer and Central Alberta.

This year marks the celebration of Red Deer's 75th Anniversary of incorporation as a City, and I can think of no better way to enhance the celebration!

In closing, I would like to take this opportunity to thank the Province of Alberta for the support we have received for this project.

RED DEER AREA: Provincial Cabinet Approves Red Deer Major Continuous Corridor

RED DEER -- Transportation and Utilities Minister Al "Boomer" Adair today announced that the Provincial Cabinet has approved a grant of \$32.85-million as the initial contribution for a major road project through Red Deer.

Speaking at a Red Deer press conference along with Red Deer Mayor Robert McGhee and Red Deer MLAs Stockwell Day and John Oldring, Mr. Adair said the initial contribution of \$32.85-million represents 90 per cent of the cost of relocating the Canadian Pacific main line and rail yards.

The project consists of the relocation of the railway mainline and yards to the west side of the city. The highway corridor will be constructed on the vacated rail right-of-way, extend north across the Taylor Bridge to 67 Street and then continue west to Highway 2.

"Negotiations between the city, CP Rail and Alberta Transportation and Utilities have been going on for some time," said Mr. Adair. "What we have now is an agreement which provides major benefits to Red Deer's overall transportation system while resulting in cost savings in transportation capital spending during the next 20 years."

Mayor McGhee said: "This is certainly one of the most important decisions affecting Red Deer since its incorporation as it will have an enormously beneficial impact on the economy and will provide a substantially improved transportation system which will benefit all citizens of Red Deer and central Alberta."

The relocation of the railway line will carry with it many benefits," said Mr. Day. "In addition to an improved overall transportation system there will be roadway capital expenditure savings, structure maintenance savings and private-vehicle-user cost savings."

Mr. Oldring said: "This project will still leave Gaetz Avenue as Red Deer's main business street but will allow the city to more efficiently plan and balance the growth and industrial development of Red Deer."


The province will fund 90 per cent of the \$68.8-million cost of the project. The funding for the provincial portion of the rail relocation will come from a special warrant while the remaining provincial contribution will come over the next four years from Alberta Transportation and Utilities' Urban Transportation Program.

At the Council Meeting of March 7, 1988, your report dated March 3, 1988, concerning the above topic received consideration and following is the motion passed by Council approving the agreement between the Province and the City.
