### Background

Inspections & Licensing is responsible for the administration of parking enforcement. On September 1, 2008, The City of Red Deer entered into a new towing contract, which resulted in an increase in the cost of towing vehicles. Under the new contract, the cost for towing a vehicle is greater than the ticket for parking in a restricted area. For example, the cost per tow, from any location in the city, can range from \$45.00 to \$65.00 per tow, plus \$40.00 if a winch is required, and \$25.00 for dollies, etc. Further, there is an additional charge of \$75.00 per hour for standby service.


There is currently no charge for towing of the vehicle included in the ticket penalty assessed to the vehicle owner. Based on the towing of 550 vehicles (2009/2010) this has resulted in an annual cost to the taxpayer of approximately \$60,000.

### Other Municipalities

The costs related to towing vary between municipalities, depending on the fees associated with the towing contract. Municipalities also deal with the cost of towing in three different ways. Some municipalities tow the vehicle to the impound lot, where the owner must pay the towing fee, as well as any storage related charges. Some municipalities incorporate the cost of towing a vehicle into the parking ticket. While other municipalities, like The City of Red Deer, absorb the cost associated with towing a vehicle.

Recommendation

It is the opinion of the Inspections & Licensing and Public Works Department that the towing costs should be paid by those responsible for the towing, rather than the general public. Administration recommends that Council consider three readings to Bylaw Amendment 3186/B-2010, to include a \$70.00 charge to cover towing costs.
