We would concur that 1st reading of the Land Use Amendment be given, following which a public hearing will be held in 4 weeks.

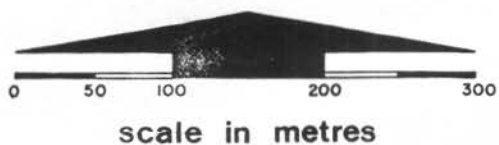
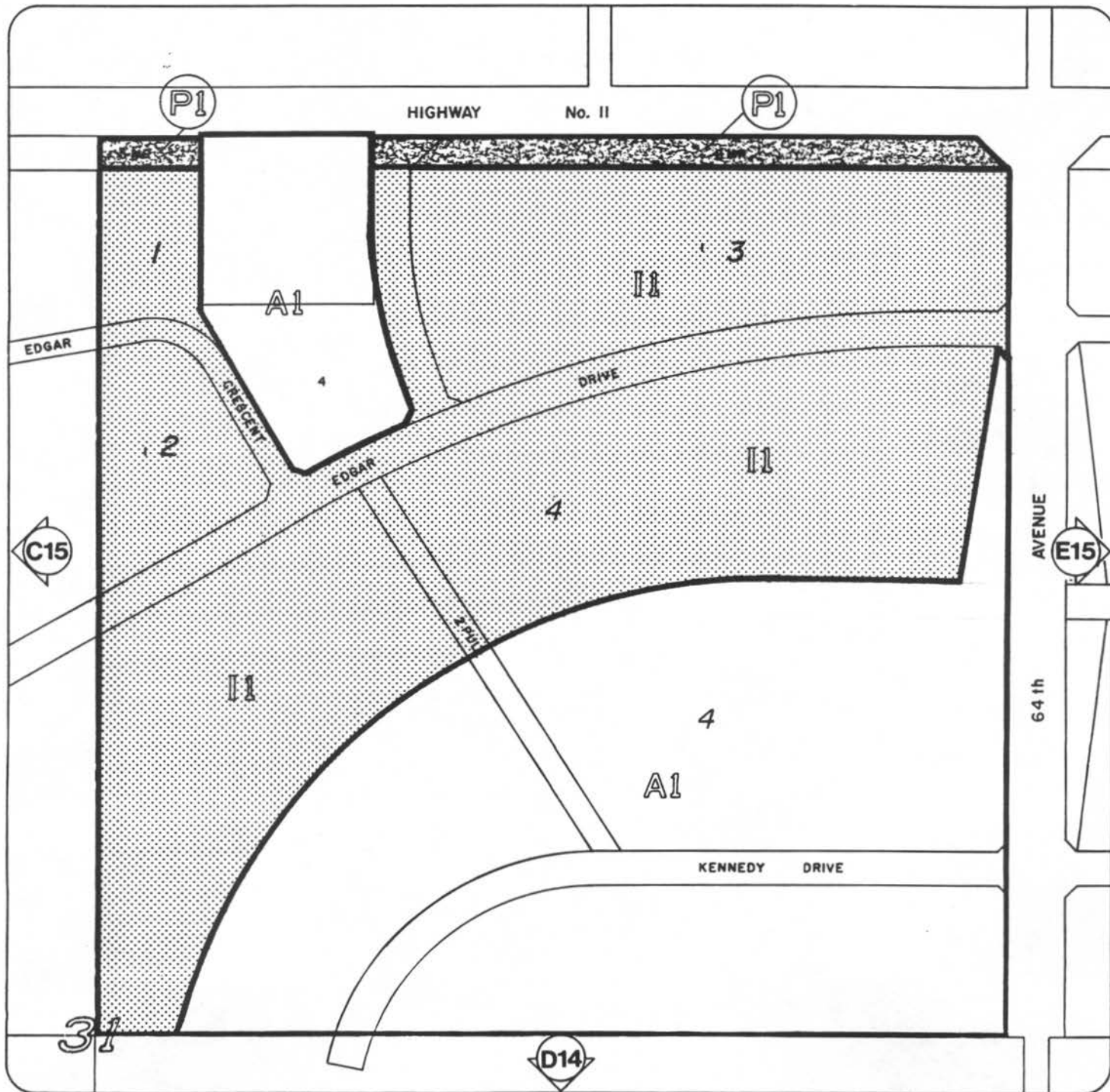

Your request through the Mayor's Office on behalf of the Royal Canadian Legion to incorporate on the Ross Street Cenotaph reference to the Korean War was considered at the Council meeting of October 17, 1988, and at which meeting, Council passed the following motion.

"RESOLVED that Council of The City of Red Deer, having considered report from Mayor McGhee dated October 13, 1988, re: Cenotaph, hereby approve the request of The Red Deer Legion to make reference to the Korean War on the plaques of the Cenotaph located on Ross Street, with all costs associated with this change being the responsibility of the Red Deer Legion, and as presented to Council October 17, 1988."
